Is cold calling illegal? Cold calling is not illegal but is discouraged on the Moor Park Estate. The reason is cold calling may be used as a method of scouting for criminal activity, and it can be deemed intrusive, reducing our right to quiet enjoyment of our property.

However, any trader who ignores a notice on your door stating that you do not wish to receive cold calls may be committing a criminal offense. Additionally, any trader who ignores any requests by you to leave and not return is committing a criminal offense.
